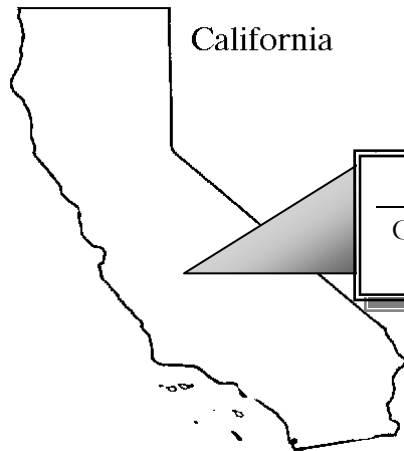


“Home Court Advantage” Freight Program

1. Eligible Area *(selected cities within CA only):*



Blanket Wrap Shipment Terms
 Only available to select Cities within California
 (see routing guide or call OM for details)

2. Rates:



		Per Chair Charge	Minimum* Charge
Dock-to-Dock	=	\$8 /chair	\$80
Inside Delivery	=	\$14 /chair	\$120
** Sacramento Dock-to-Dock (or other “off-routes”)	=	\$10 /chair	\$120
** Sacramento Inside Delivery (or other “off-routes”)	=	\$14 /chair	\$160
* Note 1:	<i>Minimum Charges</i> must be met (regardless of chair quantity) before applying any <i>Per Chair</i> charges.		
** Note 2:	“Off-route” delivery lead-times will vary by as much as 4 weeks and are based upon driver availability. Certain “on-route” cities may also be subject to extra fees (see routing guide or call OM for details).		

3. Notes + Exceptions:

1. Reception Room Furnishing is charged on the following equivalency basis (minimums still apply):
 - o 3001 = 5 chairs
 - o 3002 = 4 chairs
 - o 3003 = 3 chairs
2. ST & SG series chairs = 1 charge for every 2 chairs
3. **Office Master’s EZ Freight** subsidy program terms may apply if delivery is not possible via normally scheduled Office Master Blanket Wrap carriers.

ROUTING GUIDE/SUPPLEMENT (NORTHERN CA)

We’ve developed the following routing guide in order to help you decide which cities are normally within the “Home Court Advantage” Program’s shipping routes.

If you see your destination city’s name on this list, please make a note of whether there is an asterisk (*) or arrow (➡) next to it as special conditions or limitations may affect your shipping charges & minimums.

If there is no special note, then that particular city is eligible for Blanket Wrap shipping under the terms outlined in the “Home Court Advantage” Program.
